Fund Features

1. Investment Objective

The primary objective of the fund is to provide investors with steady long-term capital growth at moderate risk.

2. Investment Strategy & Approach

The strategy is to provide investors an access into a diversified portfolio of growth stocks listed on Bursa Malaysia and/or in any foreign stock exchanges that offer potential capital appreciation at moderate risk. The fund may feed into collective investment schemes that meet the fund's objective. At inception, HLSGF will invest by feeding into Kenanga Growth Fund ("Target Fund") with the option to increase the number of funds or replace the Target Fund in future. The Target Fund's assets are actively invested in a diversified portfolio of Malaysian equity and equity-related securities, such as warrants and convertible loan stocks which are capable of being converted into new shares. The Target Fund may invest up to 25% of the Fund's NAV in foreign markets, which may include but not limited to Singapore, Indonesia, Thailand, Philippines, Vietnam, India, Hong Kong, China, Japan, Korea, Taiwan, Australia, United States of America and any other Eligible Markets where the regulatory authority is an ordinary or associate member of the International Organization of Securities Commissions. The Target Fund does not have an active asset allocation strategy but seeks to manage portfolios by investing in companies that satisfy the criteria of having a sustainable and credible business model, and are also trading at a discount to their intrinsic value. However, under conditions of extreme market volatility and/or when the market is trading at valuations deemed unsustainable, the Fund will seek to judiciously scale back its equity exposure.

3. Asset Allocation

Under normal market conditions, the Target Fund's equity exposure is expected to range from 75% to 95% of the Target Fund's NAV with the balance in money market instruments, fixed deposits and/or cash.

4. Target Market


This fund is suitable for investors who have long term investment time horizon and have a moderate risk profile with tolerance for short-term periods of volatility.



Market Review, Outlook & Strategy relevant to Target Fund

In February, the US markets experienced a significant decline, S&P500 by 2.61%, Nasdaq by 1.11% and Dow Jones Index by 4.19%. The sell-off was sparked by concerns over rising inflation fueling expectations for the US Federal Reserve (Fed) to leave interest rates higher for longer. Stronger-than-expected economic data from nonfarm payrolls which added 517k jobs and unemployment rate registering 3.4% led to concerns over rising inflation. The annual inflation rate in the US increased to 6.4% year-on-year (YoY) in January. Although below the 6.5% figure recorded in December 2022, it was nevertheless higher than market expectations. The Fed is widely expected to raise interest rates at its next meeting in March, with consensus expecting rates to peak at 5.25-5.5% by mid-2023 and expectations for rate cuts have been pushed out to early 2024 from late 2023.

In Europe, the Euro STOXX 50 rose 1.8% in February, driven by lesser than feared inflation data. The Eurozone Gross Domestic Product (GDP) grew by 0.1% quarter-on-quarter (QoQ) in 4Q22, in-line with market expectations. The European Central Bank (ECB) has also raised interest rates by 50 basis points (bps), taking the main refinancing rate to 3.0% and intends to raise another 50bps in March. Consensus is expecting rates to peak at around 3.5% by end-2023. Decisions at future meetings will be data-dependent. The Consumer Price Index (CPI) for the month of January across Europe came in at 8.5% and was revised upwards to 8.6% which was below expectations of 9.0% (Dec 9.2%) led by falling energy prices. The ECB in December also announced that from March, it would begin to reduce its EUR5 trillion balance sheet by EUR15 billion per month on average until the end of June 2023.

In Asia, Japan, Indonesia and Korea outperformed while China/Hong Kong underperformed. Outperformers were Japan (NKY +0.43%), Indonesia (JCI +0.06%), and Korea (KOSPI -0.5%). Underperformers were China/Hong Kong (HSI -9.41%), Philippines (PCOMP -3.49%) and Singapore (STI -3.06%). The sell-off was a partial reversal of the strong gains seen in prior months and was partly due to escalating geopolitical tensions. The official non-manufacturing/manufacturing Purchasing Managers' Index (PMI) in increased to 56.3/52.6 in February from 54.4/50.1 in January.

Locally, the FBM KLCI decreased by 2.11% in February to 1454 from 1485 last month. The FBM100, FBM Small Cap and FBM Shariah index decreased by 2.04%, 4.49% and 2.51% respectively in tandem with global market on concerns of strong inflationary pressures in the US. Malaysia's 4Q22 GDP expanded 7.0% YoY above consensus of 6.7% while on a QoQ basis, growth contracted to -2.6% in 4Q22 from +1.9% in 3Q22. Market was also neutral to negative post-Budget 2023 with the biggest surprise was further taxes on high-income earners and high taxes on luxury goods along with discussions of a capital gains tax (CGT) on disposal of non-listed shares.

On fund flows, foreign investors stayed net sellers in the month of February at RM169m. The three best-performing sectors in February were Construction (+0.9%), Property (+0.0%), and Utility (-0.7%). The three worst performing sectors were Industrial (-6.6%), Technology (-5.3%), and Energy (-4.9%).

Global markets continue to remain volatile, as growth data and economic outlook in the developed markets remain mixed. Nonetheless should inflation continue to decline, the Fed could signal a pause or a more accommodative stance which would be positive for market sentiment.

Domestically, Malaysia continues to benefit from robust domestic economic activity (+4.5% GDP growth forecasted for 2023) and controlled inflation via subsidies. China's re-opening and rebounding growth should also be positive for Malaysia given the strong trade and investment links between the 2 countries in addition to the return of tourists from China. With the conclusion of the General Election and removal of the uncertainty factor, investors could have more confidence to deploy capital. The recently concluded budget saw no major increases in taxes and continued fiscal consolidation; this should also be taken positively by markets.

Actual Annual Investment Returns for the Past Ten (10) Calendar Years

Investment Risks

All investments carry risks. Policy Owners must be prepared to accept certain degree of risk associated with this investment. The following are the non-exhaustive list of risks associated to this fund.

1. Market Risk

Market risk stems from the fact that there are other economy-wide perils, which threaten all businesses. It is mainly caused by uncertainties in the economy, political and social environment.

2. Liquidity Risk

Liquidity risk is the risk that the fund invested cannot be readily sold and converted into cash. This may arise when the trading volume is low and/or where there is a lack of demand for the security.

3. Credit Risk

This refers to the possibility that the issuer of a security will not be able to make timely payments of interest or principal repayment on the maturity date. The default may lead to a fall in the value of the funds.

4. Interest Rate Risk

The level of interest rates has an impact on the value of investments. Any increase in rates will lead to a fall in the value of securities, thus affecting the value of the funds.

5. Country Risk

The foreign investment of a fund may be affected by the political & economic conditions of the country which the investments are made.

6. Currency Risk

This risk is associated with investments that are denominated in foreign currencies. Fluctuation in foreign exchange rates will have an impact on the value of the funds.

7. Concentration Risk

This risk is associated with a feeder fund whereby the investments of such fund are not diversified. A feeder fund invests mainly into another collective investment scheme.

8. Warrant and Convertible Loan Stock Risk

The price of the warrant and convertible loan stock are typically linked to the underlying stock. However, it generally fluctuates more that the underlying stocks due to the greater volatility of the warrants market. The fluctuation may have a great impact on the value of the funds. Generally, as the warrants have a limited life, they will depreciate in value as they approach their maturity date, assuming that all other factors remain unchanged. Warrants that are not exercised at maturity become worthless and negatively affect the NAV of the Fund. Convertible loan stocks must be converted to the underlying stock at a predetermined conversion ratio and conversion rate, and in the event the total costs of converting into underlying stock is higher than the market price of that the underlying stock, it will negatively affect the NAV of the Fund.

Risk Management

The company has in place its Authorized Investment Framework which forms part of the Risk Management process. The authority framework covers the nature and scope of the investment authority that is exercisable by various parties in managing the Company's investments. The potential investment risks that are taken into consideration in managing the fund include economic conditions, liquidity, qualitative and quantitative aspects of the securities. The investment manager(s) have put in place the following controls to reduce the risks through:

- a) having a flexible tactical asset allocation
- b) investing in a wide range of companies across different sectors
- c) setting prudent investment limits on various exposures
- d) taking into account the liquidity factor in selecting securities
- e) engaging in the hedging of foreign currency exposure where appropriate

Basis of Unit Valuation

- 1. The assets of every fund are to be valued to determine the value at which units of a particular fund can be liquidated or purchased for investment purposes.
- 2. The unit price of a unit of a fund shall be determined by the Company but in any event shall not be less than the value of fund of the relevant fund (as defined below), divided by the number of units of the given fund in issue on the business day before the valuation date, and the result adjusted to the nearest one hundredth of a cent.
- 3. The maximum value of any asset of any fund shall not exceed the following price:
 - a) The last transacted market price at which those assets could be purchased or sold on the business day before the valuation date; or
 - b) In the case of securities for which market values are not readily available, the price at which, in our Investment Manager's opinion, the asset may have been purchased on the business day before the valuation date;

plus any expenses which would have been incurred in its acquisition.

4. To ensure fair treatment to all unit holders, the cost of acquiring and disposing of assets is recouped by making a transaction cost adjustment to the net asset value per unit.

Exceptional Circumstances

The Company reserves the right to defer the payment of benefits (other than death benefit) under this Policy for a period not exceeding six (6) months from the date the payment would have been normally effected if not for intervening events such as temporary closure of any Stock Exchange in which the fund is invested which the Company, in its discretion, may consider exceptional.
